Further conditions: A litter is defined as puppies whelped that survive for 48 hours. If an entire litter dies after the 48 hours or only one puppy survives, the full cash fee is still due. However, one free repeat service will be given to this bitch, but only within 18 months of the whelping date.

Optional : _____

Stud fee is in no way refundable or transferable. The only guarantees are of an actual tie mating and a fertile stud. If the bitch fails to conceive, a return service at no charge will be given to this bitch by this dog. If no other litters sired by this dog are whelped subsequent to this mating, the stud owner agrees to provide a certificate of semen quality & fertility.

Artificial breedings: Fresh semen- Due to an uncooperative bitch. All fees to collect and inseminate including smears/progesterone testing are the responsibility of the bitch owner and must be paid before the bitch is returned to owner. This includes \$50 for cost of trip to the vet for collection. Fresh Chilled- All fees to collect and ship are the responsibility of the bitch owner. This includes \$35 for cost of trip to the vet for collection. Frozen Semen-All fees to ship must be paid by the bitch owner direct to the storage facility in addition to the terms listed for the semen use.

If this bitch changes ownership during pregnancy, the right to a return service is at my (stud owner's) option. Balance of the stud fee must be paid by either the former or current owner before papers are signed. The owner of the bitch pays all transportation costs. Owner of the stud dog reserves the right to withhold signing of the AKC registration application form until all payments have been made regarding stud fee or until pick puppy is in the owner's or agent's possession. If on-line registration is selected, the stud fee must be paid in full before the stud owner will complete registration. If a puppy is to be selected in lieu of a cash fee, on-line registration is not applicable unless the entire cash fee is paid. The fee will be refunded in full when the stud owner takes possession of the puppy.

In lieu of a cash fee, the owner/agent of the stud dog shall select _____ puppy/puppies at the age of 7 weeks. If a puppy is to be received in lieu of a cash fee, selection will be made at 7 weeks and if only one puppy results from the mating, this shall be the owner's/agent's pick of the litter. The right of choice of litter puppy/puppies is in no way affected by the ownership of the bitch.

All bitches shipped must be accompanied by a check or money order for 1/2 the stud fee unless other arrangements have been agreed upon. No bitch will be returned without this payment and a boarding fee of \$10 a day will be charged from the last date of breeding until 1/2 fee is paid.

Any requests for changes in the contract's terms after breeding/whelping is at the owner's/agent's option only.
